## **TOURNAMENT RULES**

## 1. MAIL-0-GRAPHIC

- a. The Mail-0-Graphic will use scores bowled during standard USBC sanctioned league play.
- b. Bowlers will pay \$20 for each league they want. Please list all leagues you wish to participate in on one form. Leagues must be uploaded to League Secretary for score collection.
- C. Bowlers must have a current USBC Card for the 2023-2024 season.
- 2. ENTRY FEE. The entry fee is \$20.00 per bowler per league. Payment of entry fees must accompany entry application. Payment can be left at one of the centers by cash or check. Bowlers can also send entry fees via Zelle using association email above. Postdated checks will not be accepted. Refunds shall not be permitted. There shall be a \$25 fee on any returned checks. MAKE CHECKS PAYABLE TO Central Texas USBC.
- 3. DIVISIONS. This tournament will have only one division.
- 4. HANDICAP & ENTERING AVERAGE. Handicap is calculated on 3 game basis using 100% of 220. Averages will be determined using standards set by Association Tournament Rules found at: www.bowlkilleenforthood/tournaments.
- 5. MULTIPLE PARTICIPATION. A bowler can enter this tournament multiple times if bowling in multiple leagues. Each \$20 entry will give a bowler 4 attempts to cash for that 1 league. Bowlers can cash multiple times if scores from different leagues make the payout cuts.
- 6. PRIZES
  - a. Prize fees shall be returned 100%.
  - b. Winner is determined by the bowler with the highest handicap 3 game series bowled during regular league play.
  - C. Scores bowled in pre-/post- bowling cannot be used.
  - d. Payout will be in a 1 in 8 ratio
  - e. In the event of a tie, winnings will be combined and split.
- 7. PROTESTS & APPEALS. The tournament director shall decide any question not covered by these tournament rules and shall have authority to hear and act on all protests concerning the tournament.
