CENTRAL UTAH USBC 38th ANNUAL TOURNAMENT Women's Tournament Rules March 1, 2, 3, 5, 7, & 10, 2024 Miracle Bowl, Orem, Utah

The Tournament is sponsored by and restricted to qualified members of the Central Utah USBC Association (CUBA). Each entrant must be a member in good standing with the USBC and Central Utah USBC Assn. Eligible USBC participants **who are not** CUBA members can qualify prior to participation, by paying the CUBA Association dues **of \$8**.

- 1. It shall be the responsibility of each bowler to verify the accuracy of his or her average, whether originally submitted by the bowler, their team captain, or others.
- 2. Average: Bowlers shall use their highest USBC composite average, based on 21 games, for the 2022-23 season, winter, or summer. If no average last year, use highest current season USBC average for 21 or more games as of February 24, 2024. If no 21-game average as listed in this rule, bowler will bowl scratch. Challenge league bowlers will use the highest average for the 2022-2023 season or USBC converted composite average, whichever is higher.
- 3. Registration for this tournament can be done on tournamentbowl.com or by sending in a paper entry to <u>centralutahbowling@gmail.com</u>. Payments can be made by cash, check or Venmo. Contact Bobbie Randall for payments.
- 4. Team captains must check in at least 30 minutes before squad time. Any substitutions must be noted at this time. USBC cards must be shown.
- The Tournament is a handicap tournament comprised of doubles, and singles, conducted according to USBC rules, with a handicap 90% of 230. Optional scratch and handicap All Events will be offered. This tournament is a woman only tournament.
- 6. Tournament Entry fees will be \$30.00 per event. Optional ALL EVENTS: Scratch \$5 and handicap \$5 per person.
- 7. OPTIONAL SCRATCH DIVISIONS available: \$5 fee per event, both doubles members must enter scratch division to be eligible.
- 8. The Tournament will be a doubles and singles tournament only. No team event will be held. The combined scores of the first doubles and singles bowled will comprise the bowlers all events score for Scratch all events and/or handicap all events. Women are encouraged to enter the team event in the Open Division of the tournament with open rules to apply.
- 9. Multiple Entry: Women may enter multiple doubles events, to place more than once in the prize list for positions standings. Entrants may cash only once in the doubles event with the same partner. Entrants may cash only once in single events. Bowlers may only bowl once in Scratch and/or Handicap All Events. The bowler's first appearance in each event counts toward the all-event total. A bowler's scratch all events score shall count towards all events for Bowler of the Year.

*To be eligible for the All-Star Team or Bowler of the Year, bowler must complete one all events in the respective annual tournament.

10. **Prize ratio** will be a minimum of 1 to 8 with prize fee returned 100%. Trophies and Championship chevrons will be awarded to 1st place winners in each event.

11. Entry information:

- A. Entry fees must be paid before bowling each event or a blank signed check left for payment of the fees to be filled in by tournament officials. All bowlers will forfeit scores for any unpaid entry fees not paid by the end of the tournament.
- B. Bowlers who have not pre-entered the tournament can do so before squad times as long as lanes are available.
- C. Re-entry will be permitted up to 15 minutes before squad times as long as lanes are available.
- D. Entries for this tournament close when the final squad begins, or when no more lanes are available.
- 12. Tournament management will decide any questions not covered by these tournament rules. Tournament management has power to hear and act on all protests concerning the tournament. The decision of the Tournament management is final unless an appeal is made in accordance with USBC Rule 329. All USBC rules will apply unless specified in the above rules.
