2024 Mixed Trios Handicap Tournament - Rules

1. ELIGIBILITY

- a. Tournament is open to all adult Greater Ozaukee Washington Bowling Association (GROWBA) active league members or GROWBA Hall-of-Fame members.
- b. Teams may consist of a maximum of 1 USBC-certified bowler who is not a member of GROWBA. Non-members are required to pay the \$5 membership fee prior to participation, or \$20 if not already USBC-certified.
- c. Teams must be made up of three bowlers with at least one male and one female bowler.
- d. Unless otherwise specified, all USBC rules will apply.

2. ENTERING AVERAGE

- a. Averages used in this event are to be reported as follows:
 - i. COMPOSITE USBC Average from the previous season. If no average last season, can go back up to 3 years, but must use highest league average with 21 or more games. Visit bowl.com to find your composite average.
 - ii. Any average from a Sport or Challenge league shall be adjusted using the USBC Adjustment Chart
 - iii. If current league average with 21+ games is 15 pins or more higher than the entering average, use current average.
 - iv. If no average, bowler will compete with a 220 average.
- b. Bowlers are required to report any rerated or adjusted average from any other tournament.
- c. It is the bowler's responsibility to verify the accuracy of their average, regardless of who submitted this entry. Failure to use the proper average or make a correction before the end of the first game of qualifying shall result in the disqualification of the bowler if the submitted average is lower than the actual average (Rule 319a-3).
- d. Rule 319d, reporting of prior winnings, is waived.

3. TOURNAMENT FORMAT - Based on 16 Entries

- a. Teams will bowl three traditional games of qualifying on the same pair of lanes. One division.
- b. Top six teams will advance to playoffs consisting of two baker games. Bowlers take turns bowling frames.
 - i. Match Play. 3 vs 6, 5 vs 4. Both matches will take place simultaneously.
 - ii. Stepladder. Two winners from match play face off, and that winner then faces the #2 seed.
 - iii. Finals - Winner of match with #2 seed bowls against the #1 seed.
 - iv. Lower seeded team picks starting lane.
 - v. All playoff competition consists of two baker games, total score.
 1. Different bowlers must bowl the tenth frame of each game per match.
 2. Baker games are bowled entirely on one lane.
 3. Switch lanes after first game.
 4. In case of tie in any match, each team bowls the 8th, 9th & 10th frames. Any bowler can start.
- c. Handicap for each bowler will be 90% of 220. Bowlers with average 220+ receive 0 handicap.
 - i. Baker game handicap will be the sum of the three bowlers' handicaps divided by three.
- d. The number of teams advancing to the playoffs is subject to adjustment if the tournament is not full.

4. ENTRY FEES

- a. All entries must be accompanied by the full entry fee to guarantee a spot in the tournament.
- b. Fees can only be made by check or cash. Electronic or credit card payments are not available at this time.
- c. \$120 entry fee consists of \$36 for lineage and \$84 for the prize pool. 100% of prize pool is returned.
- d. \$249 added to prize pool by GROWBA.
- e. All teams that make the playoffs will cash.

5. OTHER TOURNAMENT INFORMATION

- a. Maximum number of bowlers per lane is 3.
- b. Maximum individual or baker team game score may not exceed 300.
- c. Maximum individual series score may not exceed 900.
