## ENTERING AVERAGES:

All Bowlers MUST have a verifiable average on BOWL.COM website

The bowlers HIGHEST (Bowl.com) average from the 2023-2024 season of (21) games or more. If an average does not exist, then

The bowler HIGHEST 2023-2024 average at the time of bowling (21) games will be used.

At the time of bowling if your average is 10 or more pins HIGHER than last year's average, the current average must be used.

If the bowler is unable to provide appropriate information to verify the HIGHEST 2023-2024 average. The bowler will use the HIGHEST 2023-2024 average at the time of bowling (21) games will be used.

If an average does not exist, then the bowler will be bowling scratch

It's the **BOWLERS** responsibility to verify the accuracy of their own average or classified tournaments, whether originally submitted by the bowler, the team captain or others. Failure to use the correct average may disqualify the score if submitted average is lower than correct average, thereby resulting in more handicap. Prize winnings will be based on the submitted average, if it is higher than the correct average
