CENTRAL UTAH USBC 39th ANNUAL TOURNAMENT Open Tournament Rules March 1, 2, 4, 6, 7, & 9, 2025 Miracle Bowl, Orem, Utah

The Tournament is sponsored by and restricted to qualified members of the Central Utah USBC Association (CUBA). Each entrant must be a member in good standing with the USBC and Central Utah USBC Assn. Eligible USBC participants **who are not** CUBA members can qualify prior to participation, by paying the CUBA Association dues **of \$8**.

- 1. It shall be the responsibility of each bowler to verify the accuracy of his or her average, whether originally submitted by the bowler, their team captain, or others.
- 2. Average: Bowlers shall use their highest USBC composite average, based on 21 games, for the 2023-24 season, winter, or summer. If no average last year, use highest current season USBC average for 21 or more games as of February 22, 2025. If no 21-game average as listed in this rule, bowler will bowl scratch (230). Challenge/Sport league bowlers will use the highest average for the 2023-2024 season or USBC converted composite average, whichever is higher; or current average based on the same criteria.
- 3. Registration for this tournament can be done on tournamentbowl.com or by sending in a digital entry to <u>centralutahbowling@gmail.com</u>. Payments can be made by cash, check or Venmo. Contact Bobbie Randall for payments.
- 4. Team captains must check in before squad time. Any substitutions must be noted at this time. USBC cards must be shown.
- 5. The Open Tournament is a handicap tournament comprised of team, doubles, and singles, conducted according to USBC rules, with a handicap 90% of 230. Optional scratch and handicap All Events will be offered. Open teams may be composed of all men, all women or mixed with a playing strength of four.
- 6. Tournament Entry fees will be \$30.00 per event. Optional ALL EVENTS: Scratch \$5 and handicap \$5 per person.
- 7. OPTIONAL SCRATCH DIVISIONS available: \$5 fee per event, both doubles and all team members must enter scratch division to be eligible.
- 8. Multiple Entry: Entrants may bowl more than once in the team event, subject to USBC Rule 315 of the tournament rules, in order to place more than once in the prize list for positions standings. Four-player team event, at least two players in the lineup must be different. Entrants may cash only once in the doubles event with the same partner. Entrants may cash only once in single events. Bowlers may only bowl once in Scratch and/or Handicap All Events. The bowler's first appearance in each event counts toward the all-event total. A bowler's scratch all events total-, shall count towards all events points for Bowler of the Year. *To be eligible for the All-Star Team or Bowler of the Year, bowler must complete one all events (Team, Doubles & Singles) in the respective annual tournament.
- 9. **Prize ratio** will be a minimum of 1 to 8 with prize fee returned 100%. Trophies or Championship chevrons will be awarded to 1st place winners in each event.

10. Entry information:

- A. Entry fees must be paid before bowling each event or a blank signed check left for payment of the fees to be filled in by tournament officials. All bowlers will forfeit scores for any unpaid entry fees not paid by the end of the tournament.
- B. Bowlers who have not pre-entered the tournament can do so before squad times as long as lanes are available.
- C. Re-entry will be permitted up to 15 minutes before squad times as long as lanes are available.
- D. Entries for this tournament close when the final squad begins, or when no more lanes are available.
- 11. Tournament management will decide any questions not covered by these tournament rules. Tournament management has power to hear and act on all protests concerning the tournament. The decision of the Tournament management is final unless an appeal is made in accordance with USBC Rule 329. All USBC rules will apply unless specified in the above rules.
