RULES

ELIGIBILITY: OPEN TO WOMEN ADULT MEMBERS IN GOOD STANDING WITH CENTRAL SOLANO USBC

1. **BOWLING:** Singles Event with Optional Doubles Event.
 - a) Singles
 - b) Doubles "Using your SINGLES Scores" (Optional Doubles you can sign up with as many bowlers as you want before the Tournament starts.)
2. No vacancies or absentee scores will be allowed.
3. You **MUST** be ready to bowl when it is your turn or you will receive a zero for each frame missed; This includes late bowlers.
4. Only participants allowed in the bowling area.

HANDICAP: 90% of 200 for SINGLES - 90% of 400 for OPTIONAL DOUBLES

AVERAGES WILL BE:

1. 2023-24 highest USBC average (including any average in other associations, which **MUST** be verified by an association manager) or current average if ten pins higher.
2. If no 2023-24 USBC average is available, use *highest* 2022-23 USBC average.
3. If no 2023-24 or 2022-23 USBC average, use highest 2024 USBC summer average. (Minimum 21 games)
4. If no 2023-24 or 2022-23 USBC average or 2024 USBC summer average is available, use highest current average as of January 24 2025 verified by league secretary. (Minimum 21 games in one league as a regular or substitute)
5. If none of the above, entering average will be 200.

AVERAGE VERIFICATION AND CORRECTIONS: Bowlers shall verify entering averages. Averages submitted lower than actual average, NOT corrected by the conclusion of the first game (unless extended time is approved) will cause individual to be disqualified. Averages submitted higher than actual average will stand as submitted.

RULE 319a-2 APPLIES: Current average 10 pins higher than USBC average.

RULE 319d APPLIES: Reporting prior prize winnings.

CHECK IN: Must check in Thirty (30) minutes prior to squad time with membership card.

FAILURE TO APPEAR: Failure to appear will result in automatic forfeit. **(NO REFUNDS WILL BE MADE)**

PRIZES: Based on number of entries for Singles and Optional Doubles will be 1 for every 8 entries

WEARING APPAREL: Bowlers must wear appropriate attire. (Left to the discretion of the Tournament Committee)

NO LOOSE POWDER/FOREIGN SUBSTANCE SHALL BE USED DURING TOURNAMENT PLAY: Commercial powder bags may be used on hands only. Do not use powder bags or other foreign substance on shoes. (Example: baby powder)

DISQUALIFICATIONS: Bowling on tournament lanes two (2) hours prior to tournament time will result in disqualification.

PROTEST: Any protest affecting eligibility or general playing rules must be confirmed in writing to the tournament director within **72 HOURS AFTER CLOSE OF TOURNAMENT.**

ERRORS: Scoring errors must be reported to the tournament director within 24 hours.

TOURNAMENT RULES NOT COVERED HEREIN WILL BE COVERED BY USBC RULES.
