### Tournament Rules

1. Open to all LTPA Registered Participants Adult & Youth 16 years or older.
2. All CTF Rules will apply. CTF Sanctioned. **ATPA Dress Code will be enforced.**
3. Handicap is 100% of 200 for both Teams & Doubles.
4. Only 5 games will be bowled moving 1 pair of lanes after each game. Teams on the odd numbered lane will move left and the even lane will move right.
5. Team scores will be used for Scratch Singles and Handicap Doubles.
6. Current season average as of February 1, 2025 with a minimum of 21 games will be used. If no current season average last season end average with a minimum 21 games and if no last season average bowler will bowl scratch.
7. Based on 16 Entries in the Teams and 15 Entries in the Optional Scratch Singles and Handicap Doubles the Prize Payout will be as shown but may vary if more or less bowlers enter.
8. Sponsorship will be provided to the 1<sup>st</sup> & 2<sup>nd</sup> place Teams to the ATPA All Events Championships in Calgary March 15 & 16, 2025. Team entry must be the same team from this tournament and will receive reimbursement from LTPA after attending the ATPA All Events and provide receipts for expenses to receive payment.
