Central Washington USBC Association City Tournament Rules

Eligibility: Tournament is open to all current (2024-2025) USBC members (if outside Central WA USBC, Local membership must be purchased prior to squad start for \$10.00)

Qualifying Average: Entrants will use their highest USBC certified yearbook average based on the 2023-2024 season with a minimum of 21 games, including summer league. If the bowler has no qualifying average from the 2023-2024 season, then they may enter using their highest current (as of date of bowling) certified league average of 12 games. All others bowl scratch. See Rules 319a-1&2. All entrants having only a SPORT LEAGUE or CHALLENGE LEAGUE average must report this fact to the Tournament Manager. All Sport League-only or Challenge League averages will be adjusted using the USBC recommended scale (2024-2025 Playing Rules Manual), Rule 201a. Bowlers with both a Sport League, Challenge League and a regular average must use the higher average (after adjustment).

Average Verification: It is the bowler's responsibility to verify the accuracy of his/her average. Failure to use the proper average or make a correction by the completion of the first game of a series shall disqualify scores if submitted average is lower than actual average, per USBC Rule 319 a-3. USBC Rule 319c average of bowler may be adjusted upward prior to participation will apply. Tournament Prize Winning Provision Rule 319d and 319e **Tournament Average Adjustment Requirement will apply.**

Divisions: Singles will be bowled in three divisions: A-190 & above, B-189 and below, C-Women's only. Doubles will be bowled in three divisions: A-380 & above, B-379 and below, C-Women's only. Team will be bowled in three divisions: A-760 & above, B-759 & below, and C-Women's only.

Handicap: Handicap will be based on 100% of 230 per entrant. If no average, 230 will be assigned.

Entry Fees: \$140 per team, \$70 for doubles, \$35 for singles. Optional \$5 for All-Events, handicap only. Prize fund: \$17, Lineage \$13, and Expenses \$5 per bowler. Entry fee **must** accompany the tournament entry form. There will be a \$35.00 NSF fee for any check returned by the bank.

Entries Due: Closing date for pre-paid entries is March 23rd, 2025, all other entries ½ hour prior to squad time (cash only), provided space is available, and are subject to \$5.00 per entry late fee that will be added to All-Events prize fund.

Check-In Time: All bowlers shall check in 30 minutes prior to squad time.

Late Bowlers: Late bowlers will not be permitted to make up missed frames but may start in the frame in which game has progressed to and take zero pins for frames missed.

Lineup Changes: Changes in lineups must be made with the tournament director as early as possible, but in any event, not later than 30 minutes prior to the start of the squad. Substitutions may be made at the time of bowling but must take line up position of absent bowler.

Tournament Payouts: Payouts for Tournament will be: 1 out of 4 entries for Singles, Doubles, and Team. Payout for All-Events will be 1 out of 6 entries. Prize fees will be returned 100% within each event. **CWUSBC added money will be distributed on a percentage basis to each All-Events division based on number of entries. Hartshorn Ranches added money will be distributed on a percentage basis to All-Events category only.** All money will be paid within 30 days of the last scheduled squad unless there is a protest or appeal, see Rule 329, in which all monies and prizes will be withheld until the protest or appeal is resolved. No monies will be distributed until all checks have cleared the bank.

Scheduled: After entry has been accepted and scheduled, there will be no refunds if unable to bowl, it is the responsibility of the bowler to obtain a substitute.
