## **TOURNAMENT RULES**

1. To be eligible for participation, one of the following conditions must be satisfied:
  - a. the competitor must be of Filipino ethnicity and descent;
  - b. the competitor must bowl in either a Filipino league or an honorary Filipino league recognized by the FilCanAm Committee
2. This tournament will be sanctioned by USBC, therefore, all entrants must have a USBC membership card. USBC membership cost: \$30 USD for regular membership.
3. All prize fees returned 100%. Payout is 1 in 6.
4. This tournament will be one division. Entrants shall use their highest CTF or USBC sanctioned year end average with minimum 21 games from 2023/24 season. If no previous year's average, averages from December 31, 2024 with minimum 21 games. All others will bowl scratch. Handicap will be 80% of 225 per person with a maximum of 70 pins for both men and women per game.
5. **All entry fees must accompany entries and are non-refundable. All entry fees must be paid in full (\$40 USD). Cash will only be accepted on site. No exceptions.**
6. Singles Event: Bowlers entering singles must bowl at least one doubles. Bowlers may enter multiple singles events, but only cash once with the higher score.
7. Doubles Event: Bowlers entering doubles must bowl at least one singles. Bowlers may enter multiple doubles events, but only cash once with the same partner.
8. Team Event: Each team will be 4-person team of any combination. Bowlers are allowed to enter 2 team events and must change at least 2 team members.
9. Bowlers must list their tournament lineups on entry form in order they will bowl. No changes will be permitted at the time of bowling. Substitutes must assume the position of the absent bowler and report to the Tournament Director one (1) hour prior to schedule.
10. Masters Tournament: This is a scratch event, which is held after the final team event. You must bowl at least 1 event (singles, doubles or team) to be eligible to bowl.
11. All entrants shall check in one (1) hour before they are scheduled to bowl. Any bowler or team arriving late, under any circumstances, shall begin to play. Bowlers receive zero (0) for all frames missed. No make-up frames.
12. In the event of first place ties, in any category, a one-game roll-off with handicap will be bowled to determine the champion. Therefore, entrants or teams who are tied for first place must stay. Failure to stay and complete a one game roll-off shall result to a 2<sup>nd</sup> place finish. Ties for all other money positions will be combined and divided equally with exception of the last place ties, which will receive no less than the designated prize fee.
13. Rule 319 – 319a and 319c shall apply to all entrants (Re-rating & 10 pin rule).
14. All USBC rules will apply in this tournament, if not covered by the above rules, shall be left to the discretion of the Tournament Committee.
15. **Any protest must be made in writing within 15 minutes after final results are posted. Decision of the Tournament Committee shall be final.**
