All USBC rules shall be in effect unless otherwise stated.

All bowlers are required to be USBC certified.

- A legal team constitutes any mixture of a doubles team
- **Bowler who starts as leadoff stays as leadoff.**
- Handicap: 100% of 230 based on individual bowler average for 2 full games.
- Individual bowler average used to compute handicap is highest of reported/recorded USBC League Average:
 - 2023 – 2024 USBC season 21 games.
 - Any bowler without an admissible average must bowl scratch.
- All entrants are required to be familiar with the USBC rule 319E Re-rating requirements and comply with all other requirements. The Tournament Director has the right to adjust or reject any entry without penalty.
- Multiple participation is allowed, however a bowler can only cash once with same partner.
- **PLEASE NOTE: Premature termination of the tournament brought on by war, national emergency or other reasons beyond the control of the bowling center and/or tournament director shall cause the foregoing prize to be prorated based on the number of entrants who have bowled.**
