## DOUBLES HANDICAP TOURNAMENT November 5th & 6th, 2016 at Oak Bowl USBC CERTIFIED

This tournament will be conducted under the rules and regulations of the USBC. Entry into this tournament is open to all current adult members of USBC. Non-members may purchase a membership by paying a fee of \$19.00 (\$10.00 National; \$2.00 State; \$7.00 Local) prior to bowling in the tournament. Subject to lane availability, entries for each squad will close 15 minutes before the start of each squad.

**AVERAGES:** Will be based on the highest 2015-16 winter league average of 21 games or more. If no winter average, a highest certified 2016 Summer league average may be used, provided they have bowled 21 games or more. If no previous season average, an entrant will use their highest current USBC -certified league average of 21 games or more as of October 28, 2016. It is the responsibility of the individual bowler or team captain to furnish the appropriate standing sheet from the league and/or leagues to verify the current average. Bowlers without an acceptable 21 game average will bowl scratch.

Rule 319a-3 Bowlers are responsible for the accuracy of their own average, whether submitted by the bowler, partner or others. If the submitted average is lower than the established average and results in additional handicap, the bowler's score will be disqualified. If the submitted average is higher than the book average, prize winnings will be based on the submitted average. Correction of the average may occur before the end of the entrant's first game. Rule 319a-2, 319d and 319e are waived. No pacers allowed.

HANDICAP: Will be based on 100% of 230 for men and women.

# **DOUBLES MAY CONSIST OF THE FOLLOWING COMBINATIONS:** 2 MEN; 2 WOMEN; or 1 MAN AND 1 WOMAN

**MULTIPLE PARTICIPATION:** Entrants may bowl twice with the same partner, but cash only once. Entrants may cash more than once, if done with another partner.
