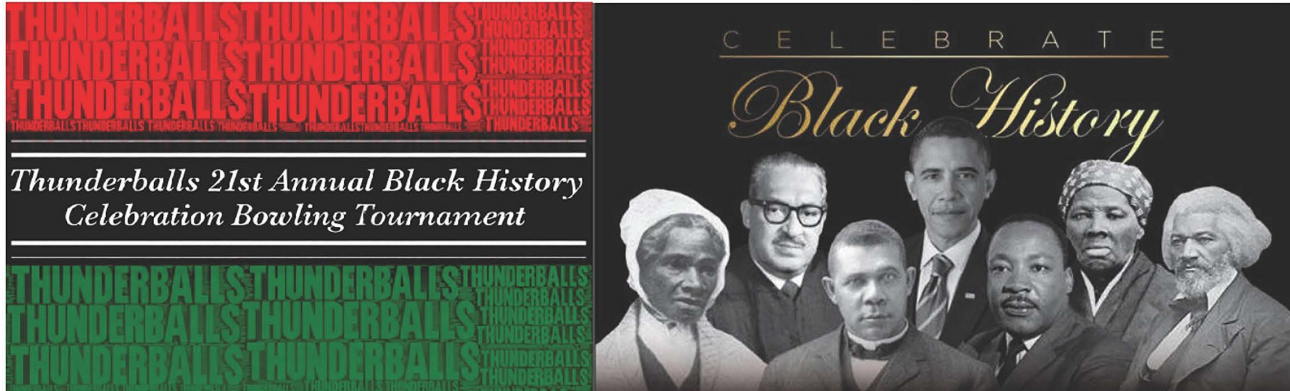

# *“Accepting Applications for New Thunderballs Members”*

## TOURNAMENT RULES

1. This Tournament is open to all USBC Members.
2. The handicap will be 80% of 220.
3. You may bowl as often as you wish, but cash-out only once.
4. Use highest USBC average (Those who belong to USBC shall use highest average.)
5. Use highest 2024-2025 book average of 21 games or more.
  - a. If none, use highest current season average of 21 games or more at time of bowling.
  - b. Verification of current average must be supplied at the time of bowling.
  - c. If none of the above, both men and women will enter at 220 scratch.
6. Bowlers must present their USBC card.
7. The Tournament Committee reserves the right to re-rate a bowler prior to participation in the tournament.
  - a. If the entrant refuses the re-rate entry fees will be refunded.
  - b. Entrants have the right to appeal any re-rate to the USBC within 15 days of the date of bowling or payment of prizes, whichever comes first.
8. If a bowler uses a higher average than correct average, the highest average will be used for handicap purposes. If a bowler uses a lower average than their correct average their scores will be disqualified.
9. Pre-entries accepted, no refund, substitutions okay.
10. Claims for errors in scorekeeping must be filed with the Tournament Committee in writing within 24 hours after the error was made. Any protest made in regards to playing rules or eligibility shall be made in writing to the Tournament Committee prior to distribution of prize fund.
11. Total pins in a three (3) game series plus handicap shall determine final standings. In case of a tie for any position, including first place, the cash prizes for the positions affected shall be divided equally.
12. Prize Ratio will be at least one in eight. The prize fund shall be returned 100%. No prize will be awarded for less than the entry fee.
13. The Entry Deadline shall be the last squad of the Tournament. Squad times will be assigned in the order the entries are received.
14. Check-in is at least one hour prior to squad time.
15. Tournament Participants will not be allowed to practice on assigned lane one hour prior to scheduled time to bowl.
16. The Tournament Committee shall have the authority to determine if re-bowling will be allowed when a whole game or frame is lost.
17. Drinking or eating in the settee area will not be allowed while bowling.
18. Bowlers are asked to wear suitable attire for tournament competition.
19. A \$20 service fee will be charged for all returned checks.
20. Payoff will be within 30 days following the tournament.

### Additional information:

1. Sidepots will be handicap and scratch for men and women
2. Handicap is 80% of 220 for both men and women
3. Brackets will be available for handicap and scratch, if available.
