GKFHUSBC SINGLES TOURNAMENT

1. SINGLES TOURNAMENT

- a. The Singles Tournament, shall be conducted by the Greater Killeen-Fort Hood USBC and shall be open to all USBC members in good standing of the USBC.
- b. It shall be sanctioned by the USBC and shall be singles event.

2. **ELIGIBILITY.** The tournament shall be open to all USBC adult members in good standing of the USBC.

3. **ENTRY FEE.** The entry fee is \$60.00. Payment of entry fees must accompany entry application. Postdated checks will not be accepted. No refunds shall be permitted after the entry has been accepted and the squads scheduled. There shall be a \$25 fee on any returned checks. Bowlers with a returned check will not be permitted to write checks for future association tournaments. The entry closing shall be 15 minutes prior to squad time. **MAKE CHECKS PAYABLE TO GREATER KILLEEN FORT HOOD USBC.**

4. ENTERING AVERAGE.

- a. Rule A - Bowlers will use the highest verifiable **2019-2020** winter USBC average of AT LEAST 21 or more games.
- b. Rule B - If Rule A does not apply. Use the highest **2020** summer league average of AT LEAST 21 or more games.
- c. Rule C - If Rule A or B does not apply. Use the highest **2020-2021** CURRENT LEAGUE AVERAGE OF AT LEAST 15 GAMES AS OF date of participation, bowlers must furnish average verification (copy of league standing sheet)
- d. Rule D - Bowlers without a verifiable average will be given the average of 210.

Each bowler is responsible for verification of their own average.

5. **AVERAGE ADJUSTMENT & TOURNAMENT PRIZE WINNINGS.** USBC Rules 319a(2) (10-pin rule), 319c (average adjustment), 319d (prize winnings), and 319e (12-month tournament average) are waived.

6. **SCHEDULING & CHECK-IN.** Entries will be scheduled in order of receipt. The schedule will not be changed except for emergencies. Lanes will be assigned by the tournament director. The event will be bowled on a pair of lanes. Check-in time is no less than 15 minutes before the scheduled squad time. All participants must have a **2020-2021** USBC membership card in their possession at time of check-in.

7. PRIZES

- a. Prize fees shall be returned 100% in the event collected and shall be awarded on a handicap basis.
- b. Top 8 bowlers will receive prize fund winnings.
- c. If there is a tie a 9th and 10th frame will be bowled to determine who advances or wins the match. Prizes for all other ties shall be divided equally among those tied.
- d. **Prize fund will be distributed on site.**

8. **VERIFICATION.** It shall be all bowlers' responsibility to verify the accuracy of their averages.

9. **SCORING.** A tournament entrant will not be allowed to re-bowl a game or series except as authorized by the Tournament Director when the scores are irretrievably lost from an automatic scoring device. Any scoring corrections must be accomplished prior to the end of the game. Sports/Modified House Shot will be used.

10. **PROTESTS & APPEALS.** The tournament director shall decide any question not covered by these tournament rules and shall have authority to hear and act on all protests concerning the tournament.

11. **UNAUTHORIZED ACTIVITIES.** Brackets and high game/series side pots not approved by the tournament director shall not be conducted.

12. Tournament director shall have authority to add or delete squads as needed.

13. **Qualification for Tournament of Champions.**
NEW! Bowlers placing in the top two places will qualify to advance to the Tournament of Champions (TOC) at the end of the season. Winners from other GKFHUSBC sanctioned tournaments will also qualify to participate in the TOC. In the event one of the winners does not wish to participate the next bowler in line will be eligible to participate. A bowler may only qualify once for the Tournament of Champions but may participate in each singles tournament for the prize money. If a bowler has previously qualified for the Tournament of Champions the next bowler in placement will be offered a spot.
