GKFHUSBC 2020-2021 SCRATCH TOURNAMENT BY DIVISION RULES

- 1. SCRATCH TOURNAMENT BY DIVISION
 - a. The Annual Scratch Tournament, shall be conducted by the Greater Killeen-Fort Hood USBC and shall be open to all USBC members in good standing of the USBC.
 - b. It shall be sanctioned by the USBC and shall be scratch singles event.
- 2. ELIGIBILITY. The tournament shall be open to all USBC adult and youth members in good standing of the USBC.
- 3. ENTRY FEE. The entry fee is \$30.00 per adult. h Payment of entry fees must accompany entry application. Postdated checks will not be accepted. No refunds shall be permitted after the entry has been accepted and the squads scheduled. There shall be a \$25 fee on any returned checks. Bowlers with a returned check will not be permitted to write checks for future association tournaments. The entry closing shall be 15 minutes prior to squad time at Hallmark Lanes, Phantom Warrior Lanes and Killeen Bowlerama; and Putters & Gutters. MAKE CHECKS PAYABLE TO GREATER KILLEEN FORT HOOD USBC.

4. ENTERING AVERAGE.

- a. Rule A Bowlers will use the highest verifiable 2019-2020 winter USBC average of AT LEAST 21 or more games.
- b. Rule B If Rule A does not apply. Use the highest 2020 summer league average of AT LEAST 21 or more games.
- c. Rule C If Rule A or B does not apply. Use the highest 2020-2021 CURRENT LEAGUE AVERAGE OF AT LEAST 15 GAMES AS OF date of participation, bowlers must furnish average verification (copy of league standing sheet)
- d. Rule D Bowlers without a verifiable average will be entered in Division 1.

Each bowler is responsible for verification of their own average.

- AVERAGE ADJUSTMENT & TOURNAMENT PRIZE WINNINGS. USBC Rules 319a (2) (10-pin rule), 319c (average adjustment), 319d (prize winnings), and 319e (12-month tournament average) are waived.
- 6. SCHEDULING & CHECK-IN. Entries will be scheduled in order of receipt. The schedule will not be changed except for emergencies. Lanes will be assigned by the tournament director. The event will be bowled on a pair of lanes. Check-in time is no less than 15 minutes before the scheduled squad time. All participants must have a 2020-2021 USBC membership card in their possession at time of check-in, this requirement is waived for bowlers who bowled in previous scratch tournaments.

7. PRIZES

- a. Prize fees shall be returned 100% in the event collected and shall be awarded on a scratch basis.
- b. There shall be at least 1 prize for every 5 entries.
- c. In the event of a tie for first place in any event, there will be a 9th and 10th frame roll off.
- d. Prize fund will be distributed immediately following the completion of the squad.
- 8. VERIFICATION. It shall be all bowlers' responsibility to verify the accuracy of their averages for division assignment.

- 9. SCORING. A tournament entrant will not be allowed to re-bowl a game or series except as authorized by the Tournament Director when the scores are irretrievably lost from an automatic scoring device. Any scoring corrections must be accomplished prior to the end of the game. House shot will be used.
- 10. PROTESTS & APPEALS. The tournament director shall decide any question not covered by these tournament rules and shall have authority to hear and act on all protests concerning the tournament.
- UNAUTHORIZED ACTIVITIES. Brackets and high game/series side pots not approved by the tournament director shall not be conducted.
- Tournament director shall have authority to add or delete squads as needed.

Qualification for Tournament of Champions.

NEW! Bowlers placing in the top two places will qualify to advance to the Tournament of Champions (TOC) at the end of the season. Winners from other GKFHUSBC sanctioned tournaments will also qualify to participate in the TOC. In the event one of the winners does not wish to participate the next bowler in line will be eligible to participate. A bowler may only qualify once for the Tournament of Champions. If a bowler has previously qualified for the Tournament of Champions the next bowler in placement will be offered a spot.
