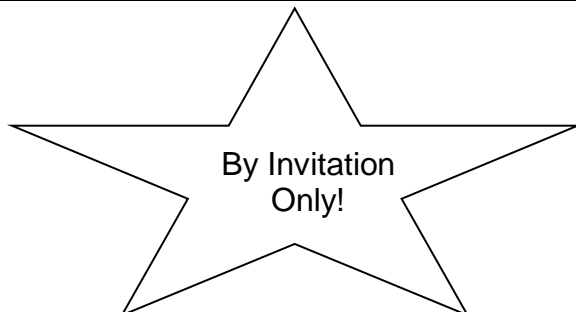

# GKFHUSBC 2020-2021 TOURNAMENT OF CHAMPIONS

1. Tournament of Champions
  - a. The Tournament of Champions, shall be conducted by the Greater Killeen-Fort Hood USBC.
  - b. It shall be sanctioned by the USBC and shall be handicap singles event with an option for a scratch division.
2. ELIGIBILITY. Bowlers must have been invited to participate in the Tournament of Champions based on standings in other association tournaments. Bowlers must be in good standing with USBC.
3. ENTRY FEE. The entry fee is \$40.00 with a scratch option for an additional \$10 fee. Payment of entry fees must accompany entry application. Postdated checks will not be accepted. No refunds shall be permitted after the entry has been accepted. There shall be a \$25 fee on any returned checks. Bowlers with a returned check will not be permitted to write checks for future association tournaments. **MAKE CHECKS PAYABLE TO GREATER KILLEEN FORT HOOD USBC.**
4. ENTERING AVERAGE : Bowlers will use their **2019-2020** highest verifiable book average.
5. AVERAGE ADJUSTMENT & TOURNAMENT PRIZE WINNINGS. USBC Rules 319a (2) (10-pin rule), 319c (average adjustment), 319d (prize winnings), and 319e (12-month tournament average) are waived.
6. SCHEDULING & CHECK-IN. Entries will be scheduled in order of receipt. The schedule will not be changed except for emergencies. Lanes will be assigned by the tournament director. The event will be bowled on a pair of lanes. Check-in time is no less than 15 minutes before the scheduled squad time. All participants must have a **2020-2021** USBC membership card in their possession at time of check-in, this requirement is waived for bowlers who bowled in previous scratch tournaments.
7. PRIZES
  - a. Prize fees shall be returned 100% in the event collected and shall be awarded on a scratch basis.
  - b. Based on 72 entries, top 10 bowlers will cash. Otherwise prize fund will be distributed using the ratio 1:8.
  - c. In the event of a tie for first place in any event, there will be a 9th and 10th frame roll off.
  - d. Prize fund will be distributed immediately following the completion of the squad.
8. VERIFICATION. It shall be all bowlers' responsibility to verify the accuracy of their averages for division assignment.
9. SCORING. A tournament entrant will not be allowed to re-bowl a game or series except as authorized by the Tournament Director when the scores are irretrievably lost from an automatic scoring device. Any scoring corrections must be accomplished prior to the end of the game. House shot will be used.
10. PROTESTS & APPEALS. The tournament director shall decide any question not covered by these tournament rules and shall have authority to hear and act on all protests concerning the tournament.
12. UNAUTHORIZED ACTIVITIES. Brackets and high game/series side pots not approved by the tournament director shall not be conducted.
13. Tournament director shall have authority to add or delete squads as needed.
