DOUBLES HANDICAP TOURNAMENT
November 4th & 5th, 2017 at Riverside Lanes
USBC CERTIFIED

This tournament will be conducted under the rules and regulations of the USBC. Entry into this tournament is open to all current adult members of USBC. Non-members may purchase a membership by paying a fee of \$25.00 (\$13.00 National; \$2.00 State; \$10.00 Local) prior to bowling in the tournament. Subject to lane availability, **entries for each squad will close 15 minutes before the start of each squad.**

AVERAGES: Will be based on the highest 2016-17 winter league average of 21 games or more. If no winter average, a highest certified 2017 Summer league average may be used, provided they have bowled 21 games or more. If no previous season average, an entrant will use their highest current USBC -certified league average of 21 games or more as of October 27, 2017. **It is the responsibility of the individual bowler or team captain to furnish the appropriate standing sheet from the league and/or leagues to verify the current average.** Bowlers without an acceptable 21 game average will bowl scratch.

Bowlers are responsible for the accuracy of their own average, whether submitted by the bowler, partner or others. All averages will be verified and may be re-rated in accordance with all USBC Rule 319 rules. Correction of the average may occur before the end of the entrant's first game. Failure to use an adjusted average in accordance with the 319 rules is cause for forfeiture of entry fees and prize winnings. No pacers allowed.

HANDICAP: Will be based on 100% of 230 for men and women.

DOUBLES MAY CONSIST OF THE FOLLOWING COMBINATIONS: 2 MEN; 2 WOMEN; or 1 MAN AND 1 WOMAN

MULTIPLE PARTICIPATION: Entrants may bowl twice with the same partner, but cash only once. Entrants may cash more than once, if done with another partner.

SQUADS: Saturday, November 4, 2017—1:00 pm and 4:00 pm
Sunday, November 5, 2017—10:00 am and 1:00 pm

An additional \$5.00 per person, per event tournament expense will be collected from each entry received after Wednesday, November 1, 2017.

AWARDS: Estimated prizes shall be at least 1:6 entries. **ALL PRIZE MONEY COLLECTED WILL BE RETURNED 100% TO PARTICIPANTS IN THE TOURNAMENT.** In the event of a tie, co-champions will be declared and no roll off will occur.

All other rules will be based on the USBC 2017-18 Rule Book
