Rules of Tournament Play:

1. The 50+ Singles Tournament is open to all USBC sanctioned bowlers 50 years of age as of April 3, 2022 and older and will be held at Bird Bowl.
2. **Prize monies will be returned 100% with 1 out of every 4 entries cashing.** Bowlers may enter an optional Scratch Prize Fund for an additional \$30.00 fee. The entire \$30.00 goes to the prize fund, with 1 out of every 4 entries cashing.
3. **The handicap ratio is 100% of 230. Sanction #:**
4. **Entering Averages:**
 - a. 2020-21 highest GMUSBC yearbook or bowl.com average with 21 games.
 - b. If no yearbook average, use highest summer 2021 average of 21 games.
 - c. If no yearbook or summer average, use highest current season league average for 21 games.
5. All others will be required to bowl scratch (USBC rule 319C., 319D. and 319E. re-rating averages and reporting of prize money, do not apply.)
6. USBC rule 319A-2, the 10-pin rule, does not apply.
7. Tardy bowlers will receive a ZERO for frames missed.
8. Bowlers will bowl 4 games: changing lanes after each game; total pins, plus handicap will determine winners.
9. Any rules not covered by the above shall be governed by the USBC Rules and Bylaws.
