WOMEN'S CHAMPIONSHIP TOURNAMENT
January 27th & 28th, 2018 at San Juan Lanes
USBC CERTIFIED

This tournament will be conducted under the rules and regulations of the USBC. Entry into this tournament is open to all current adult women members of Skagit Valley USBC. Non-USBC members may purchase a membership by paying a fee of \$25.00 (\$13.00 National; \$2.00 State; \$10.00 Local) and Non-Skagit USBC members may purchase a local membership by paying a fee of \$10.00 prior to bowling the tournament. Subject to lane availability, **entries for each squad will close 15 minutes before the start of each squad.**

EVENTS: Handicapped 4 person team, doubles, and singles; optional handicapped all events.

AVERAGES: Will be based on the highest 2016-17 winter league average of 21 games or more. If no winter average, a highest certified 2017 Summer league average may be used, provided they have bowled 21 games or more. If no previous season average, an entrant will use their highest current USBC-certified league average of 21 games or more as of December 31, 2017. **It is the responsibility of the individual bowler or team captain to furnish the appropriate standing sheet from the league and/or leagues to verify the current average.** Bowlers without an acceptable 21 game average will bowl scratch.

HANDICAP: Will be based on 100% of 220 for singles.

MULTIPLE PARTICIPATION:

Team Event: May bowl more than once, provided that a minimum of (2) team members are changed.

Doubles: Entrants may bowl twice with the same partner, but cash only once. Entrants may cash more than once, if done with another partner.

Singles: Entrants may bowl as many times as they wish, but cash only once.

ENTRY FEE: Lineage	\$10.00

Entry fee must accompany entry form.

An additional \$5.00 per person per event tournament expense will be collected from each entry received after Wednesday, January 24th, 2017.

ALL EVENTS: Optional \$3.00 entry fee. There will be one handicapped division, with prize money being paid 1:15 entries. **First team/doubles/singles event scores will be used for all events.**

SQUADS: Saturday, January 27th, 2018—1:00 pm and 4:00 pm
Sunday, January 28th, 2018—10:00 am and 1:00 pm

AWARDS: Estimated prizes shall be at least 1:6 entries. **ALL PRIZE MONEY COLLECTED WILL BE RETURNED 100% TO PARTICIPANTS IN THE TOURNAMENT.** In the event of a tie, co-champions will be declared and no roll off will occur.

All other rules will be based on the USBC 2017-18 Rule Book
