PACIFIC NORTHWEST SENIORS TOURNAMENT

December 3rd & 4th, 2022 at Riverside Lanes USBC CERTIFIED

This tournament will be conducted under the rules and regulations of the USBC. Entry into this tournament is open to all current adult members of USBC residing or bowling within the jurisdiction of Washington, Oregon, and British Columbia. Non-members may purchase a membership by paying a fee of \$25.00 (\$15.00 National; \$2.00 State; \$8.00 Local) prior to bowling in the tournament. Subject to lane availability, entries for each squad will close 15 minutes before the start of each squad and based on lane availability.

EVENTS: Handicapped mix or match doubles, men's singles, and women's singles.

AVERAGES: Average used for purpose of handicap will be as follows:

- 1) Will be based on the bowlers 2021-2022 *composite* average of all USBC leagues, including leagues with less than 21 games bowled.
- 2) If no previous season average, the bowlers *composite* average from all current USBC leagues must be used, provided that the total number of games bowled from all leagues combined equals 21 games or more.
- 3) Rule 319a2 will be waved.
- 4) Bowlers without an acceptable 21 game average must bowl scratch.

Bowlers are responsible for verifying his/her own average. Average corrections can be made up until the end of the bowler's first game of a series. Additional time may be granted by the tournament manager.

HANDICAP: Will be based on 90% of 220 for singles.

DIVISIONS: Doubles will be mix or match: (2) Men, (2) Women, or (1) Man & (1) Woman 50 years of age or over. Mix or match doubles may enter with their spouse, regardless of the age of the spouse. Singles will be in two divisions: Men and Women age 50 and over. Date for determining age is the time of first event participation.

MULTIPLE PARTICIPATION:

Doubles: Entrants may bowl twice with the same partner, but cash only once. Entrants may cash more than once, if done with another partner.

Singles: Entrants may bowl as many times as they wish, but cash only once.

ENTRY FEE: Lineage \$12.00
Prize Fund \$18.00
Tournament Expense \$5.00
Total per bowler per event: \$35.00

An additional \$5.00 per person per event tournament expense will be collected from each entry received after Saturday, November 26th, 2022.

SQUADS: Saturday, December, 3rd, 2022—1:00 pm and 4:00 pm Sunday, December 4th, 2022—11:00 am and 2:00 pm

AWARDS: Estimated prizes shall be at least 1:4 entries. ALL PRIZE MONEY COLLECTED WILL BE RETURNED 100% TO PARTICIPANTS IN EACH EVENT OR DIVISION OF EVENT. In the event of a tie, co-champions will be declared and no roll off will occur.

All other rules will be based on the USBC 2022-2023 Rule Book
