Tournament Rules

1. This is a non-sanctioned handicap tournament and opened to all bowlers. The following rules will apply:

2. The Trio Team Tournament will consist of three bowlers per team. This tournament will have one handicap division. Teams must be a mix of male/female bowlers, any combination. This is a 3 game tournament with high team series as the 1st place winner. Number of places paid out will be determined by the number of participants,

3. The entry fee is \$40 per person. The breakdown of entry fee will consist of: \$22 Prize Fund, \$12.00 Lineage, and \$6.00 Expense Fee. All Prize Fund will be returned 100%. Prize money will be distributed day of the tournament, unless a written protest is pending. See rules 8 and 10. No refund on any entry fee. Number of places paid out will be determined by the number of participants. \$500.00 FIRST PRIZE APPLIES ONLY IF 20 TEAMS OR MORE PARTICIPATE.

4. Handicap will be 80% of 220. YOU must provide your 2017-2018 COMPOSITE USBC AVERAGE as listed on bowl.com. IF YOU DO NOT HAVE A 2017-2018 COMPOSITE AVERAGE WE WILL ACCEPT THE FOLLOWING IN THIS ORDER:

A) CURRENT SANCTIONED LEAGUE STANDING SHEET SHOWING 21 OR MORE GAMES BOWLED.

B) CURRENT NON SACTIONED LEAGUE STANDING SHEET SHOWING 21 OR MORE GAMES BOWLED.

IF YOU DO NOT OR CAN NOT PROVIDE A VERIFIABLE AVERAGE (as listed above) YOU MUST BOWL SCRATCH

5 The use of abrasives on the surface of bowling balls during tournament play will result in

disqualification.

6. Non-participants or children are not allowed in the bowler's area

7. The application of any foreign substances on the approach that detracts from the possibility of

other players having normal conditions is prohibited. This is to include, but not limited to such substances as talcum powder, pumas and resin on shoes and soft rubber soles and/or heels that rub off on the approaches.

8. Problems/disputes – Any problems and /or disputes which may occur and are not covered by the above the tournament rules shall be decided by the Tournament Managers.

9. In case of tie for the first place, co-champions will be declared. When a tie occurs, the prize

money will be divided equally among the tied position winners.

10. All protests must be made day of the tournament, in writing to the Tournament Managers. Written protests may delay payout to tournament winners for up to 30 days.
